SUBJECT: Policy Letter 16 – Off Limits Establishments/Areas

1. Reference AR 190-24, Armed Forces Disciplinary Control Boards and Off-Installation Liaison and Operations, paragraph 2-6, 27 July 2006.

2. The following areas/establishments are declared off-limits to Armed Forces personnel. The change in name of any of the establishments/areas does not revoke off-limits restrictions. The off-limits restriction for each establishment/area will remain in effect for an indefinite period.

3. Military personnel observed in off-limits establishments/areas are in violation of AR 190-24, and subject to apprehension and disciplinary action under the Uniform Code of Military Justice.

4. Major subordinate commanders will ensure the contents of this memo are brought to the attention of all military personnel. A copy of the memo will be posted on all unit bulletin boards.
