DATA REQUIRED BY THE PRIVACY ACT OF 1974

AUTHORITY: Title 10, US Code, Section 3012.
PRINCIPAL/ROUTINE PURPOSES: Used for statistical purposes and to locate hunters who fail to properly clear hunting areas.
DISCLOSURE: Mandatory; non-compliance will result in individual being ineligible for hunt.

You must have the following items in your possession while, or turned in, before hunting:

1. Fort Knox Deer Hunting Permit (Archery or Gun), signed.
2. Kentucky Hunting License (out-of-state hunter needs Non-resident Annual Kentucky Hunting License).
3. Kentucky Deer Permit (out-of-state hunter needs Non-resident Deer Permit).
4. Hunter Education Certificate (All hunters age 60 or under).
5. *Signed Claims Release (required before signing into a Hunting Area).
6. *Hunter Information Sheet (filled out).

* The Claims Release and the Hunter Information Sheet will be turned in to the Hunt Control Office (Archery Hunt Only) or your Area Guide (Gun Hunt Only) the first day of your assigned hunt.

**All firearms brought onto Fort Knox must be registered with the Directorate of Emergency Services prior to the hunt.

We must emphasize the importance of properly completing the enclosed forms.

YOU WILL NOT BE ALLOWED TO HUNT WITHOUT THE ABOVE-MENTIONED FORMS COMPLETED AND IN YOUR POSSESSION OR TURNED IN TO THE HUNT CONTROL OFFICE OR AREA GUIDE.

I do hereby, for myself, my heirs, executors, and administrators, remise, release, and forever
discharge the United States, its officers, men, employees, and instrumentalities, from any and
all claims, demands, actions, or causes of action, on account of my death or on account of any
injury to me or my property which may occur during my presence on the said Military Reservation
for the purposes above stated or incident to the said purpose.
